salespersons under the Trust in Real Estate Services Act, 2002, S.O. 2002, c. 30, Sched. C. (TRESA).
Each member shall be entitled to receive notice of and to attend all meetings of members, to move or second
motions, and shall have one vote at any meeting of members, provided that a member shall not be entitled to vote at any meeting of members of the Corporation if, at the time of the commencement of such meeting:
i) he or she is in default of payment of any fees, dues, costs, charges, annual contribution, annual fees, or other
amounts, including without limitation, any insurance premiums or other insurance-related payments, fines, interest, or administrative penalty, owing to the Corporation, fines payable as a result of a conviction for an offence under
TRESA, or orders for compensation or restitution in relation to an offence under TRESA;
ii) his or her registration is suspended;
iii) he or she is not in compliance with a condition of registration, order, direction, or other requirement under TRESA.
